ENERGY EFFICIENCY EXPRESS INCENTIVE TERMS AND CONDITIONS

1. If the facility owner or contractor has applied for another SMUD incentive program, Express Incentives may not be available (e.g. New Construction and Savings by Design).
2. Applications received after November 22 will be enrolled in the following year's Express Incentive program provided the program still exists.
3. Only "permanent" measures installed in SMUD territory, replacing existing equipment, or adding new equipment, are eligible.
4. Hazardous waste must be handled and disposed of in strict compliance with all applicable Federal, State and local laws, ordinances and regulations.
5. All installed products/equipment must be new and meet SMUD's minimum technical and performance specifications.
6. All energy efficiency equipment and systems set forth in this application must be installed and operational.
7. Applications for Express Incentives must include a copy of applicable invoices, receipts or work orders indicating the quantity, model number and cost of installed materials or equipment.
8. SMUD may inspect the installation upon project completion.
9. Disclaimer of Warranties. SMUD makes no representations, expressed or implied, regarding the design, sizing, installation, construction, reliability, efficiency, performance, operation, maintenance, or use of any energy efficiency equipment or systems analyzed, discussed, selected, rejected, installed or otherwise considered by customer. Any decisions regarding the selection, design, installation, use and operation of any energy efficiency equipment or systems shall be made at the sole discretion and are the sole responsibility of the Contractor/Applicant.

Contractor/Applicant shall indemnify, defend and hold harmless SMUD, its directors, officers, employees, and agents against all claims, loss, damage, expense, and liability asserted or otherwise incurred by other parties, including, but not limited to SMUD's employees and Contractor/Applicant's employees, arising out of or in any way related to the performance of this Agreement and caused by the acts, omissions, intent or negligence, whether active or passive of Contractor/Applicant, its agents, employees, suppliers, and excepting only such loss, damage or liability as may be caused by the intentional acts or the sole negligence of SMUD.
